MINUTES OF THE VILLAGE OF GOLF MANOR REGULAR MEETING MAY 12, 2008

The regular meeting of the Village of Golf Manor was called to order by Mayor Alan Zaffiro; Clerk-Treasurer Gregory Doering recorded the minutes. After the Pledge-of-Allegiance, the roll was taken with all members present.

Councilman Doering made a motion to approve the minutes of the April 28, 2008 meeting as written, seconded by Mr. Bidnick, all members approved.

Mr. John Malott of 2539 Losantiville addressed council reference camper issues. First, he wanted to give his thanks to NIC for their help with his concern, they were professional and courteous to him and his wife. Second, there was a car accident in front of his house on Losantiville and there was debris on the road after the Golf Manor Police Dept and Golf Manor Fire Dept. had left. Who is now responsible to sweep and pick it up?

Mr. Creager answered that it is the tow truck operator.

Third, he has a problem with one unprofessional Golf Manor Fire Dept. responders. Chief Ballman responded that he had already had a conversation with the individual involved, and that he had a totally different account of what happened.

Mayor Zaffiro asked Chief Ballman to review the situation and give Mr. Malott a call.

MAYOR'S REPORT: Mayor Zaffiro:

Mr. Doering questioned a submitted cable message from the Avon Lodge reference Blood Drive.

Mayor Zaffiro approved with changes.

Mrs. Faulk questioned status of proposed walkthrough sale of right of way at Elbrook & Stover. Solicitor Butler replied that there were more expenses to the Village than first thought. He will get back to Council with details.

FINANCE: Mrs. Dubose:

- 1. Made a motion to approve the bills totaling \$21,191.29, seconded by Mr. Colvin, all members approved.
- 2. Is in receipt of 2009 preliminary budget requests from all department heads. They will be reviewed and discussed at next Finance Meeting on May 20, 2008.

EXECUTIVE COMMITTEE: Mrs. Faulk:

- 1. Reference Pool Area. After speaking with Councilman Doering, if the work was done by the Us Army Corp of Engineers, it would be 3-4 years in advance of start up and could result in the entire park area to be closed for a significant time.
- 2. We need the N.I.C. "Big Boss" to come to our next council meeting to explain the service (or lack of) they are giving to Golf Manor.
 - A. Do we wish to retain their services?
 - B. Are other companies an option?
 - Mayor Zaffiro replied that would be Mr. Andrew Mackenzie of N.I.C. and he would be happy to field our questions.
- 3. Re: Graceland Avenue Project. Can we get a date for completion? Can we get an explanation of the overage of the Bid Amount? Will the cost overrun be the responsibility of the
 - A. Contractor.
 - B. Engineer.
 - C. Taxpayers of the Village of Golf Manor.

Mr. Butler answered with an explanation of anticipated vs. unanticipated expenses. He will speak and/or meet with Mr. King and report back to council. However, issues which were not in the bid would be OK for cost overages. Mr. Butler will fight for what we believe to be correct. Mr. Creager added that the completion date is to be determined and he will meet with the engineer and contractor and get back to Council with answers.

- 4. Mr. Ed Haake provided a copy of the Recreation Commission Charter and bylaws for review. Background checks need to be done.
- 5. LSDMC met and interviewed candidates for the Pleasant Ridge Montessori School scheduled to open in August 2008.
